- 4) The Applicant acknowledges that Applicant shall give a perpetual easement for the location of water lines crossing Applicant’s Tract.
- 5) The Applicant understands any approval of this Application shall be valid for a period of 60 days following the District’s approval and shall be subject to all laws of the State of Oklahoma, and all standards and requirements of the State of Oklahoma including, without limitation, its Department of Environmental Quality and Department of Health.
- 6) The Applicant shall be responsible for all road crossings and any other expense in construction and/or preparation done by the District to provide the service sought by this Application.
- 7) The Applicant acknowledges this Application will be processed by the District’s staff and

approved or rejected by the District's Board of Directors and that the Application and Water User's Agreement contained herein shall be conditioned upon and subject to approval by the District's Board of Directors.

The Applicant has read and understands this Application, certifies that all information submitted herein is true and correct and agrees to be bound by the terms and provisions hereof.
